The Biomass Power Association (BPA) represents the national and state interests of the U.S. biomass power sector. BPA's members use sustainably-sourced organic materials, such as residues and byproducts from forest harvests and farming and biomass materials including wood waste, to generate utility scale electric and thermal energy.

Increasingly, our ranks are expanding to include fuel suppliers, equipment manufacturers, truckers, developers — virtually any company that benefits from our industry and wants to see it preserved. #### Some of our major issues - which could have a significant impact on your business - include:

### **EPA & CARBON**

We are working to make sure that the Environmental Protection Agency keeps its pledge to count biomass from forest residues as a renewable energy source in the Clean Power Plan. This could have a profound impact on the stability and growth of the industry as the U.S. increasingly favors power from renewable sources.

#### **TAXES**

Keeping costs low is essential for biomass – the only renewable power source that purchases its own fuel. We meet regularly with elected officials representing states and districts where biomass facilities are located to fight for lower taxes for biomass power producers. We also seek a "level playing field" when it comes to tax credits. For years, Congress has favored wind and solar, leaving our facilities at a financial disadvantage when negotiating power contracts.

## STATE RENEWABLE PORTFOLIO STANDARDS

Biomass Power Association supports efforts to ensure that biomass is included as an eligible renewable power source in state renewable portfolio standards. In many cases, state governments have the final say in biomass power growth in a particular region. We help our members make the case to state elected officials that biomass — and all of the small and large businesses that work with the biomass industry — should be protected. We intend to vigorously defend existing state programs supportive of our industry and reform state RPS policies that unfairly discriminate against us.
